# **Data Privacy Policy**

### Purpose

The purpose of this document ("**Data Protection Policy**") is to inform how **Reem Finance PJSC** manages customer personal Data. This Policy document mentions the purposes for which we collect, use, and disclose customer's Personal Data.

- When you request that we contact you, be included in an email or other mailing list; or when you respond to our request for additional Personal Data, our promotions, and other initiatives.
- when you are contacted by, and respond to, our marketing representatives and agents and other service providers.
- when you submit your Personal Data to us for any other reason.
- 2. When you browse our website, you generally do so anonymously but please see the section below on cookies. We do not, on our website, automatically collect Personal Data, including your email address unless you provide such information.

- carrying out client reviews, for example, annual reviews of your portfolio.
- To establish your financial situation, risk profile, investment experience and investment objectives to help you consider the suitability of the products you have invested in or intend to invest in.
- ensuring the ongoing creditworthiness of customers.
- administering exceptional approvals, fee adjustments or waivers.
